You are invited to attend St John's School Association Annual General Meeting on Tuesday 20<sup>th</sup> of January 2015 at 0915 at the school. Ask at reception for room allocation on the day.

SJSA are a charitable group established to raise money, support the school and make a difference for the children. We provide an opportunity for everyone to work together towards a common goal and is open to all parents and teachers - even if you only have a small amount of time available.

SJSA makes a strong contribution to the school, running educational events (and events just for fun!) like discos, cooking, the Christmas Shopping Event, The Winter Wonderland, filming the Christmas production and so on. We also provide assistance and refreshments at school functions such as the Sports Day and Summer Fete. In addition we directly support the children's educational development - for example with the construction of an amphitheatre and outdoor play areas, contribution towards the new library, the refurbishment of the Year 1 Quad, new netball posts, Nursery play speed boat, trim trail and playground markings. There is currently a pledge for a significant investment in the school's ITC resources.

This AGM will cover a report from the Chair and Treasurer and also see the election of Committee and Officers. Each of these Officer posts will be available for election. For those who would like to nominate themselves for these positions the following provides a brief outline of roles.

**Chair** - The Chair provides leadership for the Committee, sets the agenda for meetings and manages meetings in line with the agenda.

**Vice chair** – Supports the chair in fulfilling his/her duties.

**Treasurer** –The Treasurer is responsible for day to day admin of financial records and procedures as well as the banking and handling of money at SJSA events.

**Vice treasurer** – Supports the treasurer in fulfilling his/her duties.

**Secretary** - The Secretary is responsible for ensuring that there are effective communication links between Committee members and between the Association and the School.

**Vice secretary** – supports the secretary in fulfilling his/her duties.

Each year, as our children move on to secondary school we lose some valuable support. It is therefore important to remind you that **without a full committee SJSA will cease to exist after this AGM.**
